# **Local Dog Rescue Receives Abandoned Rare Breed**

Bailey Porter had just certified her new nonprofit, Knotty Creek Animal Rescue, out of Sweet Home in January, but she wasn't expecting to have nine new dogs under her care so soon.

Yet, that's just what happened after someone reported a dog and her eight pups found in the middle of a forest near the very rural unincorporated community of Willard, Wash.

Unable to catch the dogs, the person who spotted them took a photo and posted it to Facebook. Two dog rescue volunteers in Gresham saw the post and drove all night to Washington to search for the canines. According to Porter, it took the pair three or four hours to catch them all, after which time they communicated with I Paw'd It Forward, a nonprofit organization in Vancouver, Wash., about

the pack.

So, early on Saturday, March 30, Porter received the rescued pack and has since been busy managing the ken-

nel and fielding multiple interviews as the news spread through media outlets in Oregon and Washington.

## **SHFAD Battle Blaze, Save Nearby Home**

The Sweet Home Fire and Ambulance District (SHFAD) was dispatched to a structure fire located at the 44000 block of Wiley Creek Road on Tuesday, April 2, at 6:26

"We arrived to find smoke coming out of the double-wide mobile home," said Randy Whitfield, the on-scene commander who

arrived at 6:33 p.m. "It was coming out from all corners. Due to the location and the wind, it grew quite rapidly."

SHFAD worked to put the fire out, but 20-25 feet away was a secondary mobile home that shared a common roof with the structure fire.

"We were trying to save the camp trailer as much as we could. It was a challenge, but we were able to do that," Whitfield said.

Initially, SHFAD had six people on scene, but with other determining factors, this number grew substantially to about 20 by the end of the event. Lebanon Fire District responded with two engines and a medic unit, and Brownsville Fire responded with an engine.

The fire is presumed to have started from an electrical malfunction near the resident's dryer.







## FROM OUR FILES

April 11, 1974

David Allen Chetwood, 8, drowned after falling into the Lester Shingle mill pond. David and his brother, Danny, were apparently searching for frogs when the accident occurred. In an attempt to save his brother's life, Danny jumped in. Bystanders Jim Pritchett and Greg Osburn also then dove in to rescue the two boys, saving Danny. It took sheriff volunteer divers 45 minutes to recover David's body due to the murky, seven- or eight-foot deep water.

After 13 years of big timber logging in eastern Linn County, Buzz Martin traded his chainsaw for a guitar and went on to a career in country music that is bringing him national attention and acclaim. Known as "The Singing Logger," Martin uses hard facts about forests and logging in his evangelistic support of wood production. Martin met Johnny Cash and sang for him the song, "Butterin' Up Biscuit," one of Martin's most popular songs.

Norm Davis resigned as the high school's head football coach, but will remain as a teacher and retain his head wrestling coach duties. Davis said in his resignation letter that he'd like to have more time with his family, but also put more energy into the wrestling program.

#### April 14, 1999

White's Electronics is adding 9,000 square feet of work space, the first major addition to the hometown business in more than 20 years. With a worldwide market, White's finds itself in need of more space, particularly for metal fabrication.

Junction City police officials were found not negligent nor a contributing factor to the hanging death of Norman Stephens, a 25-year-old Sweet Home man who was serving a four-day sentence in the Junction City Jail for passing bad checks. Three days into his sentence, Stephens was found hanging from a bed sheet in his cell. Police performed CPR and he was transferred to the hospital where he died a week later.

Cory Martin, 5, a pre-kindergarten child at Little Promises, was one of five children across the nation to win a drawing contest by Christian singer Mary Rice Hopkins. Teacher Vanessa Swindall's class all submitted artwork into the contest. Cory's picture depicted Moses using his staff to change water into blood when he demanded the Egyptian pharaoh let his people go.



## **SHEM Seeks More Helping Hands for Maintenance, Board**

Volunteers who operate Sweet Home Emergency Ministries (SHEM) have been providing food and resource services since 1980, but as they look to the future they would like to find more hands to keep operations running smoothly.

Pantry Manager Cindy Rice and Board Chair Julie Dedman said they would like to see the nonprofit's base strengthened by a younger generation working volunteer hours, business professionals serving on the board and handymen available for regular maintenance.

As warm weather approaches, the nonprofit has a list of maintenance needs that need to be completed. They include: cleaning gutters, cleaning refrigerator and freezer coils, cart repairs, toilet replacement and related repairs, faucet repairs, painting, spraying weeds, raking leaves, cleaning windows, patching the cement floor, and clearing leaves and/or snow from the sidewalk.

"This is ongoing maintenance and repairs," Rice said.

Ideally an experienced and able handyman or two could offer their skills on a somewhat regular basis for basic upkeep. Some of the work requires the ability to work on top of the roof, climb ladders or fix plumbing.

Rice, who's been with SHEM since its inception, said she's patched the floor multiple times over the years because pallets and carts regularly run through the building, but she can't complete all the maintenance needs.

"Some of this stuff was actually date night for my husband and I, like returning the benches to the front," she joked as she looked through a list of maintenance needs.

Prior to COVID. the food and clothing pantry saw a fair number of high school students come through as volunteers, but the pandemic seems to have put a halt to that routine, Rice said.

"tremendously," Dedman said, speaking mostly to the fact that SHEM had to discontinue its shopping-style service. They still serve clients outside its building because some volunteers are vulnerable to airborne dis-

Also, the number of people served dropped by a few thousand during the pandemic. In 2010, SHEM served 11,726 people. In 2013 the

COVID changed operations number of people served peaked at 13,771 before it began to decline until it hit 5,256 in 2021. Most recent data indicates that services are returning to pre-COVID numbers, with 10,481 served in 2023.

> As someone who's been with SHEM for more than 40 years, in addition to Dedman who's been there 12 years, Rice wondered if their knowledge and experience will have a chance to be passed

down to younger volunteers before they retire.

Rice said she hopes more business professionals will step up to serve on the board and help "strategically plan for the future" with their new energy and fresh ideas.

## **Linn County Board of Commissioners receive annual COG report**

The Meals on Wheels program sponsored by the Oregon Cascades West Council of Governments (OCWCOG) provided more than 158,000 meals (146,559 home delivered and 11,518 in-person dining) to Linn County residents in 2023, Executive Director Ryan Vogt noted in the organization's hot-offthe press annual report delivered to the Linn County Board of Commissioners on April 2.

Meals are served at the Albany, Lebanon and Sweet Home community centers, the Mill City First Presbyterian Church and the Brownsville Christian Church. OCWCOG also provided 3,861 shelf-sta-

ble food boxes and held 11 Medicare 101 information seminars.

Some 16 foster grandparents contributed 12,519 volunteer hours to youth in schools, libraries and after-school programs. There were 10 senior companion volunteers who provided almost 4,000 volunteer hours helping seniors with transportation to run errands, shop for groceries etc. The Cascades West Ride Line provided 80,394 trips totaling 1,424,907 miles for non-emergent medical transportation. Working with 29 adult foster homes, OCWCOG provided up to 145 residents with safe housing and assisted 2,191 Linn County residents through the Aging and Disability Resource Connection.

OCWCOG received \$1 million in Brownfields Grant Funding to clean up three contaminated properties, which are located in Linn County. The Cascades West Business Lending program provided area businesses with \$1.2 million in loans. Vogt said four loans were made in 2023 and it appears there will be even more applicants in 2024.

Vogt introduced new economic development director Jaclyn Disney, who comes to the mid-valley with many years of management and economic development experience from the Redding, Calif., area. She has a Master of Public Administration degree from California State University, Chico.

In other business, the commissioners:

 Approved a \$13.1 million supplemental budget request by Treasurer Michelle Hawkins. The funds will be moved from Contingency into Materials and Services. A portion of the funding, more than \$10 million, was already used to purchase the Wheelhouse Building and another \$2.6 million is

being set aside to be used to purchase a building behind Samaritan Albany General Hospital. The county is in the due diligence phase of that potential purchase. The funds come from the federal government and were set aside for these purposes during last year's budget hearings process in anticipation of such purchases.

- Were informed by Veterans Services Director Dee Baley-Hyder that her staff helped local veterans recover more than \$493,000 in benefits owed them from Jan. 1 to March 20 and more than \$1.5 million from July 1, 2023 until March 20, 2024. She also told the board about the April 25 Honor Flight taking veterans to Washington, D.C. that will start with a program on the north steps of the courthouse on April 25.
- Approved accepting a \$77,780 grant from the Oregon Department of Energy to be used to purchase electric-powered vehicles for the General Services Department.
- · Appointed Josh Barbour and reappointed Darrin Lane and JoAnn McQueary to the Developmental Disabilities Advisory Board.

- · Approved a temporary part-time employment contract with Communications Dispatcher Brittany Kleivan, who resigned from a full-time position effective March 31. With her contract, the Sheriff's Office will still have five open dispatch positions.
- · Agreed to sponsor the First-Time Youth Wage program for the 17th year. Linn County allocates money from the Oregon Video Lottery program earmarked for economic development to subsidize wages paid by local employers who hire young employees. Traditionally the county has provided \$2 per hour and total outlay according to Treasurer Michell Hawkins is between \$30,000 and \$40,000 annually. The commissioners agreed to up the subsidy to \$3 this year. Commissioner Sherrie Sprenger said she would like to see some form of measurable objectives and outcomes and to ask employers if the subsidy actually makes a difference in whether they would hire young people.



# Kids Learn Japanese Print Art at Library

The Sweet Home Public Library invited children to try their hand at gyotaku, a traditional form of Japanese printmaking, on April 4.

Between interruptions from restless, curious and talkative little ones, Program Coordinator Kelsie Szeszulski, of Mid-Valley STEM-CTE Hub, told her guests at the library what gyotaku is and why it was important in Japanese culture.

Translated as "fish printing," gyotaku was used by fishermen to visually record the size and species of fish they caught. It was also used in competitions to prove who caught the biggest fish, and it later became an artform. Fishermen would pin down their catch, paint it with nontoxic cuttlefish or squid ink, then press paper or fabric to the specimen to capture its impression.

Mid-Valley STEM-CTE Hub brought their Mobile Makerspace program to the library to provide the children with the opportunity to try gyotaku for themselves. Using silicone molds of fish that would be found in the Pacific Northwest, the children applied a light layer of ink to a roller, then rolled it onto their rubbery specimen.

Next, they placed thin rice paper on top of the fish and gently pressed down until the print was sufficiently marked onto the paper. Once completed with their own artwork, each of the kids contributed a print onto a shared piece of paper that will become part of a large collaborative art piece made from other contributions in the area.

Mid-Valley STEM-CTE Hub is an organization that operates out of the Linn-Benton

Community College campus in Albany. STEM (science, technology, engineering, math) and CTE (career and technical education) are areas of focus that encourage passion and learning skills in areas that can offer high-demand careers for the future.

Part of Hub's programming includes their Mobile Makerspace, which allows them to bring these kinds of experiences throughout Linn and Benton counties.

"We got some grant funding from the state to come into rural schools and get some hands-on STEM activities," Marketing Specialist Kacey Montgomery explained.

Mobile Makerspace visits libraries, out-of-school organizations (such as Boys & Girls Club) and farmer's markets to provide the events free of charge. They will return to the Sweet Home library next month with a "solar critter" project.

"We're going to be using solar panels and making circuits and having a little vibrating motor with bugs attached," Szeszulski said.

Once completed, kids will learn what affects solar light and how it can be used as a green energy source. To find out when the project will take place, call 541.367.5007, email shpl@sweethomeor.gov or follow the library on Facebook at Facebook.com/SweetHome-PublicLibrary.

"They come out and do awesome projects for us," Programming Librarian Kira Mikutaitis said. "They do a great job every time they come. We have kids every time who are excited and interested. It's really a great opportunity to get more stuff here at the library."

"We think it was probably over a week that they were out there because they were skin and bones, and so was mom, and they started fighting over food and it was a complete mess," Porter said. "Now they don't fight over food."

She estimates the puppies are nine to 13 weeks old. Porter expected the dogs to be a Labrador-Pyrenees mix, but it became evident pretty quickly that that was not the case. The all-white dogs are large and look much like a Central Asian shepherd or akbash breed, both of which are not common in the United States.

A scanner was used to search for a microchip, but none was located. Howdy Ranch in Roseburg offered to do DNA testing, and results are expected within a month or so. Faithful Friends Animal Clinic in Lebanon offered to test the dogs for parasites. Porter said two puppies in particular were not doing well, but a special diet has improved their demeanor.

The dam has swelling on her front leg, which seems to be getting better, Porter said. Faithful Friends will take x-rays to help determine what the cause for swelling is. One of the puppies, who displayed a more feral and aggressive nature, was moved to a different foster home that can better handle the behavior.

The dogs are expected to be available for adoption in a week or two, after testing has been completed and any necessary treatments begun.

she is reconsidering that idea.

"I don't want to support irresponsible pet ownership," she said.

Instead, she would like to eventually start doing kill shelter runs. Porter explained that there are shelters in Southern California and Texas that euthanize surrendered dogs after three to seven days. These types of shelters are often referred to as kill shelters.

"No soul born deserves to Porter originally planned be put down," Porter said. "We want to focus on saving re-home public dogs, but said dogs in high risk situations

like that."

But for now, aside from the white pack taking up her time, Knotty Creek's main program is what she calls "Stop K9 Starvation," a dog food resource through her Grizzly Bag Program.

"Grizzly was one of our first rescues that we got through a foster," Porter explained. "He was a homeless man's dog and you could count every bone in his body. It took 24 days of consistent feeding (until) he was obese and we could rehome him. That really hit home with me."

She fills large bags with dog food to distribute to dog owners in need throughout Oregon.

"We just help people, whether they're low-income or having an emergency, but mostly homeless people's animals."

Jessie Cardin, a friend who owns Sun Lane Stones in Lebanon, is launching a fundraiser for Porter on Monday, April 8. At that point, he was clocked at 90 mph.

Corrington turned west on Rock Hill and headed south toward Brownsville. When he entered Brownsville, he turned west on Locust Avenue, then north on Oak Street, west on Hausman Avenue, and north on Linn Way (which becomes 7 Mile Lane). Corrington was clocked at this point at 85 mph. He continued traveling north of Brownsville before returning south toward the town. He turned east on Kirk Avenue and proceeded east on Northern Drive where he was clocked at 55 mph on

The driver then took OR-228 eastbound into Craw-

fordsville, and was clocked at 90 mph before passing Crescent Hill Road. He turned southeast onto Upper Calapooia Drive where his speed eventually decreased to 55 mph. Pavement on the road later turned to gravel.

The report indicates Corrington, who was driving a Harley Davidson, was "at gunpoint" at 9:43 p.m., and the Linn County Sheriff's Office took him into custody. A Ruger was seized. Corrington was charged April 3 with fleeing or attempting to elude a police officer, reckless driving, criminal driving while suspended or revoked, and unlawful possession of a firearm. Bail was set at \$10,000.

In October 2019, Corrington pleaded no contest to DUII (liquor) and failure to perform the duties of a driver-property damage, with a reckless driving charge dismissed. In August 2022, he pleaded no contest to DUII (liquor), with a reckless driving charge dismissed. According to court documents, the 2022 charges were related to an OSP-issued citation that included speeding 83/55. Corrington did not, however, fulfill his sentencing requirements to complete treatment services and a warrant was issued for further court hearings.

In November 2023, he was charged again with speeding 85/55, criminal driving while suspended or revoked, and unlawful possession of a firearm. A warrant was issued for failure to appear. He was served his warrants when arrested on April 2. Bail for the November 2023 case was set at \$5,000.



## **Good Week for Huskies Track and Field**

Sweet Home's track and field athletes faced bigger competition Saturday, April 6, than they have in nearly a decade, taking on a wide range of 6A- to 1A-sized schools at the Sandy Invita-

Although the weather was wet and windy, the Huskies had a good day, Coach Nathan Whitfield said.

The boys finished sixth out of 16 teams with 54 points, behind The Dalles (74.5) and Scappoose (61) from the 4A Division, while the girls were eighth in a field of 14 with 30 points, behind Scappoose, which was second with 95 points. Both The Dalles and Scappoose, which shows signs of being a major player in the state girls competition this year, were 5A schools until last year.

Included in the competition were 6A schools Sandy and Reynolds, and 5A La Salle, Milwaukie, Wilsonville and Putnam, and a variety of smaller-division schools.

"Our throws went extremely well" in particular, Whitfield said, noting that the boys had five personal bests from nine throwers and the girls had three.

And some of those were big ones. Junior Dylan Sharp, who posted a PR of 40-0 on March 21 at Stayton and then matched that Thursday, April 4, against Newport (see below), delivered a throw of 44-8 at Sandy for a giant improvement, with freshman Gavin Tyler right behind at 42-8, a 2-foot, 7-inch PR, as they placed third and fourth.

In the girls javelin, junior Peyton Markell exceeded the 100-foot mark with a 5½-foot personal best of 105-11, and junior Abygail Foss, who had improved her javelin best by 5 feet against Newport earlier in the week, added almost 9 feet to that Saturday with a PR of 94-9.

In the discus, junior Connor Pace broke the 120-foot barrier with a PR of 120-8.

Sweet Home left some of its top track performers at home with sickness or wrestling commitments - "sickness hit us kind of hard," Whitfield said. But the Huskies still put on some head-turning performances.

Both short relay teams did "great," and the girls 4x400 team did well, Whitfield said.

Freshman Nick Larson and sophomore Delainie Pratt both made the finals in the short hurdles, Larson placing fourth in 18.50, after running a PR of 18.26 in the prelims, and Pratt was seventh for the girls, running 20.28 after posting a PR of 19.92 in the prelims.

In the boys 3000, freshman ginning at 4:30. Kason Koenig-Walters was ninth in 10:29.48 in his first high school race at that distance and sophomore Mckenzie Miller was fourth in the 3000 (11:44.10) and fifth in the 1500 (5:25.51), posting season-bests in both events.

Also on Saturday, Sweet Home sent some of its less-experienced competitors to the Cobra Memorial Meet at Central Linn. The boys posted 12 personal bests from 19 athletes, and the girls had eight from 20 athletes.

The Huskies will be back in action Thursday, April 11, hosting Woodburn, which has moved back up to the 5A Division. Field events start at 4 p.m., with track races be-






