As protests arise, effort to oust superintendent pauses

Some two dozen protesters, a mixture of Sweet Home School District staff and local residents, lined the sidewalk in front of the Sweet Home School District administration building Monday despite the fact that a School Board meeting called to dismiss Supt. Terry Martin had been canceled earlier in the day.

The special session agenda was posted Friday, July 18, although it was not sent to local media, as is the usual practice with School Board meetings. Agenda items included the swearing-in of School Board Member Amanda Carter, who was not present for the board's regular meeting on July 14 (see page 5). It also inwhich board members were to "consider the termination of the superintendent's contract."

The current School Board is made up of three members who have served half of their four-year terms – Flovd Neuschwander (Cascadia), who was elected chair on July 14, Dale Keene (At Large)

July 27. 1950

The second application of anti-mosquito spray (DDT) is scheduled this week in the early morning to prevent spray from damaging items on clotheslines and softening wax on parked cars. The first operation used 350 gallons of a 5% DDT and 3% pyronone in an oil mixture, and this second application will use 500 gallons.

Frontier Days queen candidates were outfitted pioneerwith handmade fashioned outfits by members of the Sweet Home Women's Club. The skirts were blue, red and brown cotton check with three tiers of ruffles, accessorized with matching sunbonnets and purses.

July 24, 1975

The City of Sweet Home and Linn County had a tiff and are no longer living together. Linn County commissioners want to charge the city \$10 a day for keeping Sweet Home prisoners in county jail, so the city countered with an \$85 charge per month for the deputies using the police station. Dissatisfied with this turn, the Sheriff's Department is moving to the

U.S. Forest Service's Sweet Home Ranger District office. A plan to build an airport on the land owned by TOMCO and Jim Stock, east of Sweet Home, was considered by Linn County Commissioners. They decided to further explore the proposal and applicable laws with the City of Sweet Home.

July 26, 2000

The U.S. Dept. of Justice and Willamette Industries came to an agreement regarding Clean Air Act issues relating to some of Willamette's composite panel plywood plants. Willamette agreed to install air emission control equipment emission control devices that destroy volatile organic compounds, as well as pay an \$11 million fine and fund \$8 million in environmental projects.

A bull owned by Ron Blackwell, of Crawfordsville. earned the title of supreme champion bull at the Linn County Fair. The bull, named Kalapuya Tailor 602 C, is only five months old and is expected to weigh more than 800 pounds by September.

New School Board members sworn in; Neuschwander elected chair

The newly constituted got rolling Monday, July 14, with the swearing-in of five newly elected members and the election of new board officers

Commissioners OK health agreements

Linn County Communications

Public Health program agreements were front and center at the Tuesday, July 15, meeting of the Linn County Board of Commissioners.

Public Health Administrator Todd Noble presented the commissioners with four requests, all of which were approved.

The county approved an Intergovernmental Agreement with the city of Lebanon. Linn County will pay for public transportation services for individuals with disabilities. Linn County will reimburse the city \$23.18 per eligible ride.

The agreement is contingent on Linn County receiving funding from the Oregon Department of Human Services. The total is not to exceed \$500,000 for the contract which runs from July 1, 2025 through June 30, 2027.

The commissioners approved an agreement with the Oregon Health Authority for the Intoxicated Driver Program Fund.

Linn County will provide services to individuals who have been adjudicated in local courts for Driving Under the Influence of Intoxicants. OHA will provide Linn County funding not to exceed \$100,116 for services provided between July 1, 2025 and June 30, 2027.

The commissioners approved an Intergovernmental Agreement with the Oregon Health Authority to provide **Problem Gambling Prevention**

Services to increase public awareness of problem gambling.

OHA will provide Linn County with funding not to exceed \$403,000 for services from July 1, 2025 through June 30, 2027.

The commissioners approved an Intergovernmental Agreement with the Oregon Health Authority to provide services for the CHOICE Model Services program.

OHA extended the original expiration date from June 30, 2025 to Dec. 31, 2025 and added funding, not to exceed \$170,214.85.

■ Approved an agreement to provide 21 beds at the Linn County Jail for Oregon Department of Corrections inmates.

The bed rate will increase from \$103 per day to \$110 per day per bed. The agreement will run through June 30, 2027.

■ Were asked by Troy Jones, a member of Friends of Gap Road, to pass a local resolution that would ban commercial solar facilities and large-scale battery storage operations on farmland zoned Exclusive Farm Use, much like neighboring Marion County has done.

- Designating the Local Government Investment Pool and Key Bank as depositories for district funds;
- Designating Pauly Rogers and Co. of Portland as the district's auditors of record;
- Designating Brown & Brown of Portland as the district's insurance agent of record;
- Designating the Hungerford Law Firm of Oregon City, which specializes in educational law, as attorney of record:
- Authorizing cooperative purchasing agreements with other local education agencies, county, state, and federal agencies;
- Authorizing the School Board members to serve as the district's Local Public Contract Review Board; and
- Approving the retention of Portland-based food services supplier Sysco to provide the district with food products and non-food supplies for the upcoming school year.

Student Numbers Down

Martin reported that district staffing is nearly complete - down to one vacancy, a Title 1 position at Foster, that he said would be filled soon.

"We are anticipating a very small kindergarten class coming in," he told board members, adding that there are 64 children registered, though "that will change as we come into the school year," he predicted.

"We have been anticipating smaller numbers with the birth rate and such, and it looks like that's arrived," he said at the July 14 meeting.

In response to a question from Adams, Martin said the schools will move from two kindergarten classes to one next year.

Long Range Planning

Strong said the district will begin working on a Long Range Facility Plan that will focus on the needs over the next 10 years, and he invited board members to partici-

He noted that over the past decade "we've made some significant facility improvements while the overall tax rate has decreased."

"We're at a place right now where we would like to begin the planning process for the next 10 years," he said, adding that community members, staff and students will be involved, as well as up to four board members.

The process will include several evening meetings, probably starting in August, and possibly tours of other schools during the day "to learn what they're doing."

"It's gathering ideas and coming back and kind of prioritizing what you like and work with an architect, then, to maybe come up with some plans."

"Really, the goal is to position our facilities well for the next 75 years or more," he said. "The purpose of the committee is to come back to the board with recommendations, so you all will have the opportunity, then, before anything is finalized."

He said board members got first shot at joining the committee.

Iosh Darwood, maintenance supervisor for the district, told the board that "We're at a real pivotable point in the district right now."

"We've been improving a lot and there are a lot more improvements that we want to do. So I really encourage you guys to get involved.

"The more you guys get involved, the better."

Massey, Keene, Maynard and Barstad all volunteered.

Board members unanimously approved the hiring of GLAS Architects of Eugene to conduct a comprehensive facility assessment and update the district's Long-Range Facility Plan.

Strong said the work will be paid for by two grants totalling \$80,000 and that GLAS, a firm "with a long history" of working with the district, scored the highest of five bidders for the project.

In other action, the board:

- Accepted the retirement of Angie Yon, special education teacher at the Junior High, with the contingency to be placed on a post-retirement agreement for the 2025-26 school year.
- After some discussion of alternatives, agreed to continue holding board meetings at 6:30 p.m. on the second Monday of each month.





Bohemian Tavern making memories for 100 years

The hinges of the Bohemian Tavern door squeal as a patron adds their presence to the facility. It's just past 10 a.m. and some of the tavern's regulars are already seated in their usual spots with a cold drink.

For Jerry Thompson, it's a Michelob Ultra with V8. For Richard Cahill, it's Busch Light. Jeff Kragness, he chose Boneyard draft on this day.

At each mounted barstool is a worn-down circle of faded orange formica, suggesting that the countertop could tell a thousand stories. Above it, tacked to the ceiling, are a handful of dollar bills and a pair of insoles once belonging to timbercutter Elmer Branson, who celebrated his 1987 retirement by leaving his insoles there.

The Bohemian Tavern is rumored to be the city's longest continuously-running business, and the owners are celebrating its 100th anniversary on Saturday, July 26.

Kragness, now in his 60s, said his earliest memory at the Bohemian is playing football in the rain in the parking lot. He would've been about 8 or 9 years old at the time. He explained that his dad would spend Saturdays working on

his log truck.

"Inevitably he had to come to town for parts, so we'd end up here," he said.

According to Kragness, the place pretty much looks the same as back then, save for a smaller kitchen and missing wood stove.

It was in 1980, after his dad died and he turned 21, that Kragness returned to the Bohemian for a beer.

"I wanted to get to know his friends, so I came where they hung out. Been here ever since."

For him, it's the people that make the Bohemian special.

Kragness occupies the stool

at the farthest end of the bar, taking possession of the seat almost every day by noon.

Thompson, 61, also remembers playing out in the parking lot as a kid while his mother, Sue Thompson, worked inside. From time to time, he would pop in to ask his mom for a soda pop or candy bar. For him today, it's those memories of his mother working the bar that make the tavern special.

Right about when he was 25, Thompson started making the Bohemian a regular stopping ground.

"It was a good place in the morning to come for a 'breakfast club' beer," he said.

That was back when the millworkers would get off their graveyard shifts and head to the Bohemian for an end-of-the-day drink.

Cahill, pushing 85 and still charming the ladies – some might say – became a part of the Bohemian family when he hit drinking age.

He doesn't have stories to share about football with friends in the parking lot because he grew up down the street from Maples in Cascadia, where his own dad would grab a cold one. But after he got married and moved to town, he started sharing his sips between the Waterhole and Bohemian.

During his 40-plus years with Melcher Logging, he would sometimes end his shift in the afternoon with a drink before heading home, just like the "breakfast club" guys some time ago who would end their shift with a beer so early in the morning.

On this day, Thompson and Kragness shoot the breeze between the occasional sip of beer. Speaking over music that fills the mostly-empty the room (it's 10 a.m., afterall), they mention the two old guys who come in sometimes. One buys a beer and the other orders a soda, Thompson says.

When those guys arrive, regulars know what they're getting ready to do – go mushroom picking.

"One of them can't hardly walk," Kragness said.

"Yeah, they're on canes and stuff, and they're just into going after the mushrooms," Thompson said.

Here inside the walls of the Bohemian Tavern must live thousands of stories left behind like ghosts. Kragness and Thompson suggest they know a few of them, but refuse to unveil the secrets that are, supposedly, not suitable for print.

Cahill is willing to admit he's seen a few fights at the bar.

Those are the guys who just wanted to see who was tougher, Kragness noted. Still, it's a mellow bar – tavern, to be precise – he said. Granted, he's never been there to see what takes place at night. Neither of these guys have, in fact. They're the daytime crowd.

Any who attend the centennial celebration this weekend may have opportunity to establish a few more stories – good ones – with the provisions of live music, hard alcohol, food, and games and prizes.

After all, a hundred years is a long time, and the next story is always just one round away.
