Garden Club cultivates more than vegetables

For more than a decade, Holley Elementary School's garden has been a place where students discover more than vegetables sprouting from the soil. They also find patience, cooperation and joy in the process.

First grade teacher Joanna Reisbick has led the Holley Garden Club for the past 12 years, the entire time she has taught at the school. She has been teaching in Sweet Home for 22 years, including 12 years with first-graders at Holley.

Students may join the Garden Club in the spring of their first grade year, and younger children are welcome if they have a parent who volunteers. This fall, 14 students are enrolled, though Reisbick said the club has had as many as 26.

"They plant in the spring and then harvest in the fall," Reisbick said.

The students grow a wide variety of produce, including corn, green beans, spinach, melons, Swiss chard, tomatillos, beets, carrots, cucum-

bers, pumpkins, strawberries, and more. Everything is grown organically with fertilizer that comes from mushroom compost donated by Central Bark and chicken manure from local families.

For the children, the harvest is the highlight. On a recent afternoon, the students cheered when Reisbick told them they could each pull up

a carrot, carefully choosing ones planted too close together to make room for the others to grow. After rinsing them off with the hose, the children munched on their fresh snack with wide smiles.

Third-grader Sawyer Billington said his favorite part of the club is simple: "When we pick the vegetables, we get to eat them." Second-grader Logan Bennett said he especially loves carrots "because they don't taste like anything, they don't taste like vegetables." He added that making zucchini muffins was another favorite, even if "they were hard to make because they had like a million ingredients."





After a disappointing night health, to relationships. against No. 1 Stayton, Sweet Home's boys rebounded to tie Cascade in Oregon West Conference soccer.

"In the past when we faced adversity and made some mental mistakes, we haven't been able to right the ship," Stutzer said. "This time the boys dug in, held Cascade off the rest of the game in a tough match and walked out with a tie and some league points on the road.

ounty veterans services sees client increase

Since moving to its new office in July 2024, Linn County Veterans Services has seen an increase in the number of veterans and family members who have filed for benefits, program manager Dee Baley-Hyder told Commissioners Roger Nyquist, Sherrie Sprenger and Will Tucker at their Oct. 7 meeting.

Baley-Hyder said the Veterans Services office at 505 Ellsworth Street SW is more visible than at its former location on 3rd Avenue, resulting in more walk-in inquiries by veterans.

Linn County's Veterans Services program dates back to 1961.

In March 2024, Baley-Hyder reported that Veterans Services had assisted 9,453 veter-

ans and their families. As of Oct. 7, some 9,938 veterans and family members have been assisted in filing claims for benefits.

From July through September 2025, Veterans Services has helped local veterans recover \$453,285.71 in tax-free benefits and from January through September 2025, the total is \$1,999,004.33.

Baley-Hyder said there are about 10,076 veterans living in Linn County.

Veterans Services has received another \$25,000 Medical Transportation Grant from the Oregon Department of Transportation, Baley-Hyder said, which will allow services to continue through Dec. 31. The funds help Linn County provide veterans with transportation to health care ser-

Baley-Hyder said Veterans Services is also going to apply for a medical transportation grant from the Oregon Department of Veterans Affairs. If successful, the grant would run from January 2026 through June 2027.

In July, Baley-Hyder and veterans services officer Nate Larsen completed annual national accreditation training. She said it is an opportunity to learn about new laws and effective ways to ensure veterans get the benefits they deserve.

September was a busy month, Baley-Hyder said.

Office specialists Jess Valenzuela and Renee Bush participated in the annual Suicide Prevention Walk in Lebanon. There were 101 people registered. Veterans Services provided refreshments.

Staff participated in the Linn-Benton Veterans Stand Down at the Fair & Expo Center. Some 59 Veterans Services clients attended. Staff members made office appointments for veterans and answered questions about claims.

Baley-Hyder served as a veteran's guardian on the recent Willamette Valley Honor Flight to Washington, D.C. She said 20 Linn County veterans participated and each was assisted by a guardian. The Linn County veterans were joined by Lane County veterans and their guardians for a total of 107 people on the trip.

"It was a great honor to meet all the veterans and hear their stories," Baley-Hyder noted in her written report to the commissioners. "I will say, the Vietnam War Wall was very emotional and so surreal to see."

In other business, the commissioners:

• Approved an Intergovernmental Agreement with the City of Albany to allow Linn County to conduct Search and Rescue training programs at the Albany airport that involve helicopters with partners such as Life Flight and the National Guard. The agreement was presented by Sheriff Michelle Duncan. In a written report, Ric Lentz, Linn County Emer-


gency Manager and SAR Coordinator, noted that helicopters are playing a larger role in Search and Rescue operations "due to the rise in backcountry injuries and illnesses."


• Approved an Intergovernmental Agreement between Linn County and Greater Albany Public Schools, to transfer an estimated \$101,675 in Title 1D funds from the Oregon Department of Education to GAPS, which in turn contracts with the Linn County Juvenile Department. The funds are used to provide a variety of educational services, including educational transition services for young people at the Linn Benton Juvenile Detention Center and additional educational related services at the Jackson Street Youth Shelter, Albany House.

• Approved Order #2025-353 Supplemental Budget to accept a Beginning Fund Balance of \$1,631,001 into the General Fund and then approved Order # 2025-354 to accept the transfer of those funds out of the General Fund and into a new department in the Internal Service Fund.

• Approved a First-Time Youth Wage Grant Agreement with Grover Cleaning Service.



"We worked hard to control what we could control, focusing on serve receive, tip coverage, and keeping our unforced errors to a minimum. I was very happy they were able to come out and compete with that team."

Several players delivered strong performances despite the deficit. Keira Johnson went 13-for-13 from the service line and contributed high-quality passes on serve receive. Karrisa Jewell added three aces, while Aubrey Newberry served 7-for-7 with two aces and recorded four kills. Aaliyah Brown contributed five kills, and Amara Gonzales added key blocks and defensive plays.

Dargis highlighted the team's communication and mental toughness: "Our goal is to communicate well and stay positive with our team-

The club is a family affair for Rebecca Stalheim, the parent volunteer this year, and her fourth grade twins, Joanna and Didrik. Both said they grew up in the garden and feel at home in the dirt.

"My mom is a crazy gardener and I would help her a lot in the garden, so growing up I would pretty much live in the garden," Joanna said. "I am just one with the garden."

"My favorite part about gardening club is when I pick the crops," Didrik said.

Reisbick said it's that excitement, whether harvesting, watering, or just watching a dragonfly land nearby, that makes the club thrive.

"They are so excited to harvest or water or do anything have the Garden Club join for the garden," she said.

The club has also become a community project. The Rotary Club built raised beds, local while gardeners Heather Wright and Sheryl Casteen donated seeds and plants. Wright has even filled in for Reisbick when she was absent

Other volunteers, including Julie Harvey, Dawn Bar-Marble, and fellow Holley teacher Deborah Rehart, from the vine and cooked to-

"They were not too sure about the spaghetti squash, but they loved the sauce and ate it up by dipping bread into it," Riesbick admitted.

For Reisbick, the lessons go far beyond gardening skills. "They learn patience, taking turns, timing, being respectful, how to be safe and responsible, cooperation, and learning what they are capable of, especially when they work together," she said.

And at the root of it all, she added, is joy. "It's not just about growing vegetables," Reisbick said. "It's about growing kids who believe they can do hard things, and that's the real harvest."



Second community service officer helps bridge SHPD and public

Jennifer Gaspard has worn many uniforms in her career, but the one she puts on today feels like the perfect fit.

After more than two decades in law enforcement, the Sweet Home native has returned to serve her hometown as the Sweet Home Police Department's new community services officer.

Gaspard, who joined the department in April, said the role feels like a natural continuation of a lifetime of public service.

"I started out in state corrections, then worked for the Linn County Sheriff's Office and later worked in the state for nine years in corrections," she said. "After that, I worked in Deschutes County in both corrections and patrol, then came back to the valley to work with the Oregon Liquor and Cannabis Commission as a regulatory specialist for five years.

I retired in March but decided I still wanted to work part-time. This position opened up, and it just fit per-

corrections system. He tried to steer her toward a different path, but she said she was drawn to the work she had grown up around.

As a community services officer, Gaspard's job looks different every day. The position serves as a bridge between the police department and the public, a role that encompasses everything from assisting individuals in accessing rehabilitation services to organizing local community events.

"We're kind of a jack-of-allenforcement. Her father trades," Gaspard said. "We served as a deputy sheriff help out within our capacity,

and we're pretty open to doing a lot of different things if necessary."

Gaspard and her colleague, Sean Morgan, work side by side in the role, sharing responsibilities that range from community outreach to addressing home-

"When I met her, she was clearly intelligent and pro-Morgan said. fessional," "She's shown herself to be highly confident, a problem solver with a terrific work ethic. She jumps in and gets it done. She likes to stay busy and brings great insight from her experience in law en-

forcement."

Gaspard said she enjoys that her current role allows her to focus on the positive side of police work.

"When you're a sworn officer, you deal with a lot of the negativity sometimes," she said. "In this position, I get to have great interactions with the community and do a lot of the fun activities. I get to raffle off bikes to kids and make people happy. I feel like I get the good part of

Still, the work can be challenging, especially when it comes to helping those experiencing homelessness.

"You want people to get themselves into better situations and help them help themselves, but it's a struggle," Gaspard said. "It's kind of like the 'you can lead a horse to water, but you can't make them drink' situation. You see the struggle, and you just want better for them. Sometimes I don't think they can see that in themselves."

Her compassion and persistence have paid off. Morgan recalled returning from vacation to find that one woman they had both been trying to help had finally agreed to enter treatment a breakthrough he credited to Gaspard's ability to con-

"She got through to her," Morgan said. "That was a big deal because this person had been at the top of my priority list for a long time."

Despite the frustrations that can come with the job, Gaspard said she's learned to focus on the successes

"It's few and far between, but when they make it, they make it," she said.

Bevond outreach, Gaspard has quickly become a driving force behind community events. She and Morgan organized this year's National Night Out in downtown Sweet Home – the first one in many years - and were thrilled with the turnout.

"People really seemed to enjoy themselves," she said. "It was a pretty big success."

The duo also volunteered at the Oregon Jamboree, something that Morgan has done for years and Gaspard joined this year. They also plan to continue hosting community gatherings, including the upcoming Halloween candy giveaway, the Sharing Tree program for local teens, Shop with a Cop for Christmas, and the department's annual safety fair.

"In this time, bringing people together and having them connect is big," Gaspard said. "Divisiveness is so problematic. I like to see events where the community can get to know each other and realize that we need to take care of each other."

Gaspard said the community's response to the new community services program has been overwhelmingly positive. She believes the position plays an essential role in showing the public that law enforcement isn't just about enforcement — it's also about support and pre-

"We're in a unique position," she said. "We're not the enforcement part of the department; we're more of the support. Through education and outreach, we can connect people to services and keep them out of the enforcement side. Not everything has to do with punishment. Our role is also to help people find the resources they need."

That philosophy extends to the department's volunteer efforts. Gaspard encourages residents to get involved wherever they can.

"We're short on volunteers," she said. "If you'd like to get involved with the police department or in the community, we're always looking for help. It makes a huge impact."

Morgan said having Gaspard on board has made a noticeable difference - both in the department and in the community.

"She's taken so much off my plate," he said. "Now that there are two of us, we can be in two places at once and get twice as much done.'

For Gaspard, that teamwork and the chance to serve her hometown make the long days worthwhile.

"There's a lot of good being done here," she said. "You might not always see it, but it's happening every day. I think it's hugely important to get involved and do as much as you can. It really does make a difference."
